Insurance companies are getting very risk averse. Each year, we are required to submit an information update with many questions such as copies of our membership list, bylaws, charter, etc.

The first seven questions are what they call "important questions" such as "#1, is your aircraft kept in a hangar?" and "#2, do all club aircraft have a current annual (periodic) inspection?"

Questions 3 through 7 apply to pilots and we must answer these each year, even after our initial responses when we join the club. They are reworded to better apply to each person. You need to answer these, sign this form, and turn it in to Dramstad Aviation within the next two weeks.
